d) Local Aboriginal and Torres Strait Islander child and family welfare services – any local Aboriginal and/or Torres Strait Islander community based and controlled service, a main purpose of which is to provide child and family welfare services for their local community such as alternative care services, support for children leaving care, recruitment and training of foster carers, placement and support for children in need of out-of-home care, family crisis and support, advocacy in relation to child welfare, family reunification and link up, parenting information and programs, early intervention, family counselling and family support.
